BYE-LAWS NO. 37. RESTRICTIONS FOR NANNIES

- a) Nannies are not permitted in the Club without having applied for a proper exemption pass issued by the Club. Nannies must wear the Club's exemption pass at all the times whilst they are accompanying Members' children in the Club.
- b) Nannies of members' children are allowed to use F&B outlets as specified in the Club's Bye-Laws.
- c) Nannies must wait for the children in the relevant waiting area whilst the children are having sports lessons as specified areas in the Club's Bye-Laws.
- d) Nannies may use the changing rooms only when assisting the children. At all other times Nannies may only use the Toilets as specified areas in the Club's Bye-Laws.

Club's Bye-Laws for Nannies/Helpers

No. 37. Restrictions for Nannies/Helpers

37.1 Nannies

37.1.1 Nannies are not permitted in the Club without having applied for a proper exemption pass issued by the Club. Nannies must wear the Club's exemption pass at all the times whilst they are accompanying Members' children in the Club.

Members may contact the following offices to apply for an exemption pass application for their nannies :

37.1.2 Nannies of Member's children are allowed to use F&B outlets while accompany children of member at the specified area:

The RBSC Polo Club

- Swimming Pool Snack Bar
- Coffee Shop

37.1.3 Nannies must wait for the children in the relevant waiting area whilst the children are having sports lessons :

The RBSC Polo Club

- Riding : at the spectator stands at riding ring 2, 3 or 4 (depending on the class taken)
- Swimming : at the 25 meters pool next to the system control room, or at the 50 meters pool's grandstand
- Tennis : in front of courts 1, 2 and 3 or at the 50 meters pool's grandstand
- Badminton : In front of the badminton court
- Squash : In front of the squash court
- Tae Kwon Do : PRC Building (3rd Floor)
- Soccer : Field Sports

37.1.4 Nannies may use the changing rooms of the Club only when assisting the children.

At all other times Nannies may only use the Toilets in the specified area :

The RBSC Polo Club

- Staff toilets at the pool grandstand
- Toilets at PRC building (ground floor)
- Toilets at riding ring 4
