



Election Procedures

This year's Annual General Meeting will be held on Wednesday, 29th October 2025 at 6:00 p.m. at the Henri Dunant Hall. For those who wish to be listed on the ballot for this year's election for General Committee, please pick up your application form from the Club's Membership Office at the RBSC. The forms will be available beginning Monday, 1st September 2025, during the Club's office hours of 9:00 a.m. to 6:00 p.m. Interested candidates should follow the procedures as per Article 28 as follows:

Article 28

Every 2 years, there shall be an election for a committee, to be called General Committee; consisting of 12 persons, not more than 6 of whom will be of one nationality. The Election Day will be on the same day of the Annual General Meeting Day of such year. The election procedure shall be as described hereunder:

- 28.1 An Ordinary Member or Honorary Member who wishes to stand for election to the General Committee shall pick up the application form which will be available at the Club office from the first Monday of September.*
- 28.2 Such Member shall complete the application form and have his application form seconded by 2 Ordinary Members and/or Honorary Members. The candidate shall submit the application form, together with his photographs and other specified documents, to the Club Management** within the third Monday of September.***

The Club Management shall post the details of all candidates on the Club notice board within the fourth Monday of September and will take them off one day after the Annual General Meeting.****

- 28.3 Ordinary Members and Honorary Members are eligible to vote and they must register themselves to vote on the Election Day from 08:30 a.m. to 6:30 p.m. at a polling place in the Club. After the registration, a ballot paper which contains the names of all candidates shall be given. The voter has to enter to the polling booth and select not less than one and not more than 12 names of the candidates appearing on the ballot paper without the signature and immediately put the ballot paper into the ballot box.

Any ballot paper or casting ballot which does not conform to the above conditions shall be deemed void.

- 28.4 There shall be an Ad-Hoc Election Committee consisting of not less than 10 persons who have the duty to control and oversee the registration, casting and counting of ballots. The Chairmen of Sports Sections who hold office on the date which the Club announces the Annual General Meeting Day shall be Members of the Ad-Hoc Election Committee on a voluntary basis. If the Chairman of any Sports Section is not willing or cannot serve on Ad-Hoc Election Committee as specified in the 3rd paragraph of this Article, such Sports Section may select a representative to act on his behalf. The General Manager of the Club shall be Secretary of the Ad-Hoc Election Committee who has the duty to arrange the polling place, polling booth, ballot box; contact and coordinate with the Chairmen of all Sports Sections to volunteer or having a representative to be the Members of the Ad-Hoc Election Committee not less than the number as stated hereof. The Members of the Ad-Hoc Election Committee shall elect among themselves to be one Chairman of the Ad-Hoc Election Committee. The Ad-Hoc Election Committee may appoint one or more persons to perform any duty within the scope of its duties.

If the Ad-Hoc Election Committee cannot be established within 7 days prior to the Election Day as there are not enough Ad-Hoc Election Committee Members, the outgoing General Committee shall appoint Ordinary Members or Honorary Members to fill the rest or all to be 10 Members of the Ad-Hoc Election Committee as a case may be.

A person who will be a Member of the Ad-Hoc Election Committee must not be the General Committee candidate.

All resolutions of the Ad-Hoc Election Committee shall be adopted by a majority vote. The Chairman of the meeting shall make a final decision and the resolution of the Ad-Hoc Election Committee shall deem final.

- 28.5 Subject to nationality limitation, the 12 candidates receiving the highest votes shall be deemed elected.
- 28.6 The Ad-Hoc Election Committee shall continuously count the ballots once the ballot box is closed until finish and half of the Ad-Hoc Election Committee Members must sign to acknowledge the result of the election. Then the Chairman of the Ad-Hoc Election Committee or Secretary of the Ad-Hoc Election Committee shall report the result of the election to the Annual General Meeting on that day for acknowledgement.

If the Chairman of the Ad-Hoc Election Committee or Secretary of the Ad-Hoc Election Committee cannot report the result of the election to the Annual General Meeting on the Election Day for any reason whatsoever, the outgoing Chairman shall call the Extraordinary General Meeting to acknowledge the result of the election of the new General Committee within 7 days from the Annual General Meeting Day. The notice of such meeting shall be posted in the conspicuous place in the Club by the Club Management at least 3 days before the date of such meeting. No other issues shall be considered at this Extraordinary General Meeting, and any number of Ordinary or Honorary Members attending shall constitute quorum.

Following the above Articles 28.1 and 28.2, A candidate who is unable to pick up and/or submit his application in person, may appoint a representative to pick up and/or submit his application form on his behalf provided that an authorization letter signed by the candidate in the same signature as kept in the Club's record is attached to his application on submission.

The authorization letter must be submitted separately upon picking up and submitting application and must consist of the evidence as follows:

- 1) Names and signatures of applicant and the authorized person
- 2) Verified Copies of I.D. Card of applicant and authorized person
- 3) Name and signature of witness
- 4) Revenue Stamp of Baht 10 for each transaction
